Title: "Ordinary Object Beliefs and Scientific Theory"

Abstract: My dissertation argues in favor of abundant ontologies that accommodate ordinary objects—the things we seem to see, feel, and touch around us—and other composite objects like molecules and cells. To this end, I advance several arguments against ordinary object eliminativism. First, I argue that evolutionary debunking arguments against ordinary objects are self-defeating and cannot be rescued by employing a popular eliminativist paraphrase strategy. I then develop and evaluate several externalist strategies to resist object debunking arguments, and I argue that we should believe in ordinary objects because they are indispensable to our best scientific theories. Finally, I argue that attempts to rescue

debunking arguments such as those proceeding from the Interface Theory of Perception are doomed to fail because their appeals to universal Darwinism are insufficient to justify their empirical premises.
